Form Of Service Agreement For
Short-Term Firm Point-To-Point Transmission Service

- 1.0 This Service Agreement, dated as of _____, is entered into, by and between MISO and _____ (“Transmission Customer”).

- 2.0 The Transmission Customer has been determined by MISO to have a Completed Application for Short-Term Firm Point-To-Point Transmission Service under the Tariff, to be a Transmission Customer under the Short-Term Firm Point-To-Point Transmission Service provisions of the Tariff and MISO agrees to provide service upon the request by an authorized representative of the Transmission Customer.

- 3.0 The Transmission Customer agrees to supply information MISO deems reasonably necessary in accordance with Good Utility Practice in order to provide the requested service, to provide information via the OASIS for each requested transaction or in accordance with the Transaction Specification Sheet attached as Exhibit 1 if Wholesale Distribution Service, System Impact Studies, or direct assignment charges are applicable to such requested transaction and agrees to take and pay for the requested service in accordance with the provisions of the Tariff and this Service Agreement.

4.0 Service under this Service Agreement for a transaction shall commence on the later of (1) the requested service commencement date, or (2) the date on which construction of any Direct Assignment Facilities and/or Network Upgrades are completed, or (3) such other date as it is permitted to become effective by the Commission. Service under this agreement shall terminate on such date as mutually agreed upon by the Parties.
